This privacy statement describes how Savosolar Plc (later Savosolar) together with its subsidiaries (Savosolar Aps and Savosolar GmbH) processes personal data received from individual persons.

The privacy statement covers personal data collected on the web and also from other channels.

In this privacy statement we comment only processing of personal data at Savosolar.

We kindly ask users to read Savosolar's privacy statement before using our site. By using the website, the user shows having accepted these principles of data protection.

Purpose of processing personal data

The register holder or its authorized partner can process your personal data within the limits of EU privacy regulation and personal data law when it comes to doing business and developing it, communication, customer relations, contract management and fulfilling, as well as dealing with possible statutory duties.

Register data

The register contains data obtained from the person itself and data received by his/her request or consent.

Register may contain following data from all registered persons:

- first name and last name
- company/organisation
- task and/or position in the company
- post address, phone number, email address
- information related to subscription of newsletters
- date of birth and personal code (insider lists)

In case of customers and suppliers, the register may additionally contain following data:

- customer number
- information on orders, order deliveries and invoicing
- addresses of websites

Regular data sources

Data for the register is obtained from the registered person. Data from customers is obtained from tenders, contracts, customer meetings and other situations, where customers give information. In addition, data sources include the newsletter order form on our website, the feedback form and emails.

Regular disclosures of data

Due to technical and operative processing, part of data may be stored at Savosolar's subcontractors, or it can be processed by using technical user interface. Data can be disclosed to authorities in order to fulfil legal obligations, or if separately required by the authority.

Transfer of data outside of EU or EEA

Data collected in the register can under valid legislation be transferred outside of EU and EEA.

Data is disclosed outside of EU and EEA only to the extent delivering of orders or technical solutions give reason for it.

Principles of data protection

The register is processed exercising due care.

Information systems are used in web environment. All information systems Savosolar is using, are protected by firewalls and passwords. Personal data is stored as confidential. Only persons who need the data as a part of their work duties can have access to it. The excess of user rights depends on the person's task in the organisation. The register holder makes sure that the collected data is processed in a confidential way.

Right to check

Right to correct the data

The registered has the right to demand corrections to erroneous information in the register. Request for correction needs to be done in writing to: Savosolar Plc/Data protection, Insinöörinkatu 7, FI-50150 Mikkeli or by email to: info@savosolar.com

Other rights related to personal data processing

The registered has the right to demand for deleting of his/her data (to be forgotten). The right for deletion is not without exceptions. Savosolar can withdraw from deleting the data, if storing is necessary for contractual or lawful obligations. Savosolar will, however, not actively process personal data, if it's denied by the registered.
